- **9.** Authorized staff, with the approval of Meketa and the Chair of the Investment Advisory Committee to (1) reduce the DPFP investment in Eastern Shore to any level staff deems appropriate and (2) invest the proceeds of any such reduction temporarily in a passive small capital strategy.
- **10.** Staff updated the Board on investments managed by Lone Star Investment Advisors.
- 11. The Board and staff discussed legal issues.
- **12.** Staff provided a briefing on building security.
